## Security Measure Policy

Then, the company launches security measures for all of us to follow, as follows:

- 1. In and Out of the Building Security Measure To check the safety of the building, as well as controlling in and out of people and vehicles rigidly.
- 2. Security Measure to be Associated with Employees To check the background before being employed and also updating their data in order to make sure that they are qualified to fit the work.
- 3. Business Partner Security Measure To select them by interviewing and checking their information from recognized sources in order to ensure that they have a good background to operate business with, and also having a written agreement with them is a must.
- 4. Security Measure to be Associated with Products To have a report on the control of in and out of products and storing products at the safe place, with signing a signature after delivery in each point, as well as having a document after receiving products, which can be checked and tracked.
- Security Measure on Vehicles to Ship Products To keep vehicles, preferably used in shipping products, stay in good condition regularly for work. Staff in charge will have skills in managing security for products, and vehicles can be monitored and tracked.
- 6. Security Measure on Information and IT System To have methods of keeping its information security and carefully have its preventive system of electronic information.
- 7. Security Measure on Checking System and Investigating Incidents to be Emerged
  - To have regulations on investigating, analyzing and reporting incidents in order to seek preventive and solving-problem measures.
