

Sri Trang Agro-Industry Public Company Limited, so called "Sri Trang", intends to develop the rubber business and Thailand economy to reach the world class level under the concept "Green Rubber Company". Today Sri Trang has become the world biggest company in the entire rubber industry with production capacity more than 2.4 million tons a year from 35 factories located in the world's top 2 countries where natural rubber products are produced i.e. Thailand and Indonesia, including Myanmar as the new production base. Sri Trang distributes all kinds of primary natural rubber which are technically specified rubber, ribbed smoked sheet and concentrated latex. Moreover, Sri Trang has also invested with overseas joint-venture for rubber processing business and finished products, and expanded to the upstream business i.e. rubber tree farming in order to manage a large scale rubber farm in full system with environmentally friendly process in many provinces nationwide under the organization structure as follows;

## Upstream Business



#### Rubber Plantation:

Farming areas in total of 8,300 acres in 19 provinces are mostly situated in north and north-east of Thailand. They have begun to produce the materials since December 2015.

#### **Midstream Business**







3 main material products from rubber tree are technically specified rubber, ribbed smoked sheet and concentrated latex are sum of more than 1.5 million tons from 35 natural rubber factories, comprising 31 factories in Thailand, 3 factories in Indonesia and 1 joint-venture factory in Myanmar. We have built a network of procurement centers all situated in prime locations of material sources.

We have also built a distribution network for our natural rubber products in 6 countries i.e. Singapore, USA, China, Vietnam, as well as Thailand and Indonesia where are the production bases. Our key customers are located all over the world in Asia, USA & Europe.

Some finished products we supply are medical rubber glove, high-pressure hydraulic pipe and escalator handrail.

#### Other Supporting **Business**







Companies who play supporting roles for our core business; Sales and distribution networks for natural rubber products in 4 main countries as our subsidiaries are Sri Trang International, Sri Trang USA Inc., Shi Dong Shanghai, and Sri Trang Indochina. Starlight Express Transport Co., Ltd. provides transportation and logistics services for rubber products distribution as well as all documentation service for import and export.

Premier System Engineering Co., Ltd. provides maintenance service for our machines and equipments as well as improves and develops production process.

Anvar Parawood Co., Ltd. processes and supplies kiln dried lumber from rubber trees for any uses under Sri Trang Group.

## Research Projects for Corporate Social Responsibility

1. Research for sulfate measurement in rubber material using BaCl<sub>2</sub> STA has invented the method to measure sulfate content in cupped rubber with quick, easy and inexpensive way to encourage the farmers to stop using sulfuric acid to form the cupped rubber from latex.



2. Research for other solidifying agents to replace sulfuric acid Due to the effects of using sulfuric acid that cause dead bark of rubber tree, skin irritation, metal machine corrosion and bad odor in rubber, to discover new chemicals (formic acid) to replace sulfuric acid helps reduce these effects, and is also environmentally friendly.



3. Research for residue powder reduction from production of concentrated latex Nowadays there has been a great deal of residue powder wasted from latex industry. It is the sediment from magnesium ion in the production process of concentrated latex. So, Sri Trang Group has invented a new process for internal complete consumption so that the residue power would not be released to the environment.



4. Research for new environmentally friendly substance for rubber viscosity control Previously, STR20CV was used to control rubber viscosity but this substance is strong acid corrodes the machines, but a newly invented substance has a soft base status (pH = 8) which is safe for human and environment whilst it maintains the same property in viscosity control.



#### 5. Research for fresh latex preservation

This project is to preserve the quality of fresh latex as long as possible in order to feed in the production line of concentrated latex in long run. In the past, fresh latex could be kept for 3-4 days only with the old preservative agent, but now Sri Trang Group has invented new substance to keep the quality of fresh latex for up to 10 days.



6. Research for quick testing machine for fresh latex quality (TSC, DRC & NH<sub>3</sub>) Sri Trang Group has built a prototype machine which could reduce testing duration, process and chemicals used in the test from 3 methods for 3 values (TSC, DRC & NH3) with 80 minutes spent to 1 method for 3 values with a minute spent only, and the testing result earns confidence value (R2) of more than 95%.



## Internal Control and Risk Management

Sri Trang Agro-Industry Plc. has well realized the importance of good corporate governance in driving the organization to the sustainable success. Hence, we are always ready to cope with possible changes we have to face from both internal and external factors which might affect the competency to reach the goals of organization.

With the sophisticated external factors and ongoing changes for business, Sri Trang Group would apply risk management system as a supportive tool to create management strategies, work improvements, business opportunities, value-added organization, and to achieve the overall objectives. We mean all employees in every level to take responsibility to manage the mutual risk as an organizational culture.

#### Vision for Risk Management

Sri Trang Group would be the organization with integrated risk management as a whole in order to support the governance and create value-added organization.

#### Objectives of Risk Management

- To apply risk management system in the same direction for the entire organization, and take risk management as a part of decision making, strategic planning and administration for all companies in the group.
- To set the administrative procedures to keep the remaining risk at the organization's risk appetite, based on risk reduction measure and the effects of possible risk, to achieve the objectives of both organization and individual sectors.
- To inform the managements and the risk management committees the important information about critical risk, potential risk and overall risk, as well as monitor the risks of entire group efficiently and effectively.
- To provide all sectors the responsibilities to identify, evaluate and manage critical risks regularly, based on risk appetite and practical application with budget control.
- To communicate and convey the knowledge about risk management to employees in regular basis, and create the perception of being a risk owner and a risk manager for their mutual works.

#### Risk Management Policies

Sri Trang Group realizes the importance and necessity to apply risk management system with Sri Trang Agro-Industry Plc. and all companies under the group. So the policies have been imposed as the following;

- Risk management is the responsibility for all employees in every level.
- Risk management is encouraged to use as a tool for all turn-key administration for Sri Trang Agro-Industry Plc. and all companies in the group.
- The advanced information technology system would be developed to support risk management program for Sri Trang Agro-Industry Plc. and all companies in the group.
- Risk management report would be efficiently filed in the system for management committees to review.

#### Risk Appetite

Classified in 5 aspects as the following;

Financial Risk Appetite - Accept monetary loss or income reduction at certain level but not more than the level with significant impact to Sri Trang Group liquidity or financial status. Risk Appetite for the Achievement of Main Objectives (for every field of work) – Accept the lower reach on objectives at certain level but not lower than the level with significant impact to Sri Trang Group work flow.

Operational Risk Appetite - Accept delay, efficiency decrease or minor mistakes at certain level without significant impact to the production outputs.

Reputational Risk Appetite - Accept negative news/rumors in limited or local areas happening in short term, but do not accept breaking news with negative and continual impact to the company's public reputation and credibility in sight of stakeholders, especially main suppliers and shareholders. Risk Appetite for Safety - Accept minor accidents, but do not accept major accidents causing severe injuries with work suspension required, loss of organs or even death.

#### Risks Relating to Our Industry and Our Business

Prices of commodities in general, including natural rubber, have been volatile and we, like other participants in the natural rubber industry, have limited influence over the timing and extent of the price changes for natural rubber.

- Supply and demand for natural rubber An increase in the supply of natural rubber or a decrease in world consumption level of natural rubber could create supply surplus which could, in turn, result in a decrease in average selling prices of the Natural Rubber Products that we sell;
- Prices of crude oil, energy and oil-based chemicals -Crude oil prices may affect the prices of natural rubber and other input materials such as oil-based chemicals used in rubber processing. In addition, the prices of synthetic rubber usually move along with crude oil prices, and the price fluctuations of synthetic rubber affects the pricing and demand for natural rubber;
- Currency movements As natural rubber is traded mainly in US Dollars, any fluctuations in the natural rubber exporting services of key management staffs. currencies against US Dollars may result in corresponding fluctuations in natural rubber prices in the respective exporting countries;
- Speculation As natural rubber and certain of the Natural Rubber Products we sell are traded at various commodity future exchanges, they are susceptible to price speculation in addition to local and global economic factors; and
- Government intervention The governments of natural rubber producing countries such as Thailand, Indonesia and Malaysia may from time to time introduce policies to support unpredictable factors which affect the price of natural rubber and the Natural Rubber Products that we sell include economic growth rates, foreign and domestic interest rates and trade policies.

The Natural Rubber Products that we sell include RSS, TSR and Concentrated Latex. Global demand for such products, in particular TSR, is significantly dependent upon the tire manufacturing industry. Our customers include tire manufacturers in the emerging markets such as the PRC and India and leading global tire manufacturers. The majority of our sales of Natural Rubber Products are made to tire manufacturers. If the level of activity in the tire manufacturing industry declines, the demand for the Natural Rubber Products that we sell may decrease and our business, financial condition and results of operations may be adversely affected.

While our financial reporting currency is Baht and our raw material purchases for the Natural Rubber Products that we produce are transacted in Baht and Indonesian Rupiah, approximately 75% of our total revenues are denominated in US Dollars. In addition,

the Company's Shares will also be quoted in Singapore Dollars on the SGX-ST while dividends, if any, will be paid in Baht. Fluctuations in the exchange rates between the Baht, Indonesian Rupiah, US Dollars, Singapore Dollar or other currencies, could adversely affect our business, financial condition and operating results as well as the foreign currency value of any dividend distributions. Any fluctuations in the exchange rates between the Baht, Indonesian Rupiah and Malaysian Ringgit could adversely affect our price competitiveness in relation to other natural rubber processors from Indonesia and Malaysia. We attempt to mitigate foreign exchange risks using financial derivatives to hedge our foreign exchange exposures arising from purchase and sale of products in currencies other than Baht. Should we be unable to successfully hedge our foreign exchange exposures, we may have a greater exposure to foreign exchange fluctuations and our financial condition and results of operations may be adversely affected.

## Our Group is dependent upon the

One of the key reasons for the growth of our Group has been our ability to attract and retain a team of experienced professional managers.

Natural rubber business requires a significant amount of cash to operate, principally on the purchase of raw materials such as unsmoked rubber sheets, cup lumps and field latex, the Natural Rubber Products which we purchase from third party producers and from our joint venture entity, Thai Tech Rubber, from time to time, to meet customers' demand and also on the storage of the Natural Rubber Products to facilitate our sales in overseas the natural rubber industry in their respective countries. Other markets. The working capital cycle for the Natural Rubber Products that we produce, from the purchase of raw materials to the receipt of payment from our customers, is approximately two to four months. We may also require substantial capital expenditures to maintain, upgrade and expand our processing and storage facilities, logistic services and other facilities to keep pace with competitive developments, technological advancement and changing safety and environmental standards in our industry. We fund our operations principally through cash flow from our operations and short and long-term bank loans. As at 31 December 2016, we have an aggregate of Baht 28,832.3 million bank loans, majority of which are short-term loans, with interest rates ranging from 1.4% to 11.9% per annum depending on the currency on which the loans are denominated. Difficult conditions in the global credit markets could adversely impact the cost or other terms of our existing financing as well as our ability to obtain new credit facilities or access the capital markets on favourable terms. A significant increase in our borrowing costs could impair our ability to compete effectively in our business relative to competitors with lower amounts of indebtedness.

We may be affected by adverse weather conditions and/or could result in the assessment of damages or the imposition of fines, diseases which could lead to price fluctuations and an increase in our operating costs. Unsmoked rubber sheets, cup lumps and regulations and social practices in the countries in which our Group field latex are the primary raw materials for natural rubber products. The availability of these raw materials from suppliers as well as our ability to harvest field latex from our own rubber plantations become more stringent in the future and consequently have an in the future may be adversely affected by unfavourable weather conditions such as drought, floods, prolonged periods of rainfall, storms etc. and/or diseases which has infected the rubber plantations from which suppliers purchase the raw materials or our own rubber plantations in the future. Such events, especially if continued for a prolonged period, could affect the overall yield of such raw materials and consequently lead to price fluctuations. Any substantial decrease in the supply of, and increase in the cost of raw materials could increase our operating costs, affect our production capacity and consequently have a material adverse effect on our business, financial condition and operational results.

There may be disruptions at our processing facilities as well as the processing facilities of our associates and joint venture entity which would have an adverse effect on our operations and those of our associates and joint venture entity. Our sales of Natural Rubber Products, which are produced from natural rubber, accounted for 90.0% of our Group's revenue for the financial year ended 31 December 2016. There are a variety of synthetic rubbers available in the market which can be used as substitutes for natural rubber in the manufacture of rubber products

Expiry of concessionary tax rates and/or exempt tax status for certain of our subsidiaries and associates will have an adverse impact on our profitability. Our subsidiary, Sri Trang International, enjoys certain tax benefits under the Global Trader Programme launched by International Enterprise Singapore, pursuant to which Sri Trang International is only taxed on 10.0% of its qualifying income (i.e. income which is derived from offshore sales or sales to companies under the Global Trader Programme). In addition, our Company and certain of our subsidiaries and associates which are incorporated in Thailand have been granted certain privileges, including exemption from certain taxes, at various times by the Board of Investment of Thailand, in relation to our respective operations.

In the event of any expiry of such tax benefits, Sri Trang International, our Company and our relevant subsidiaries and joint ventures entities will be liable to the applicable taxes at the prevailing rates. This will subsequently have an adverse impact on our profitability. Our Group may be adversely affected by the imposition and enforcement of more stringent environmental regulations. Our Group is subject to a variety of laws and regulations that promote environmentally and socially sound operating practices. Our Group's principal environmental concerns relate primarily to the discharge of effluent resulting from the processing of natural rubber. Any environmental claims or the failure to comply with any present or future regulations

the suspension or a cessation of our Group's operations. Environmental operates tend to be less stringent than those in developed countries. It is possible that these regulations and/or social practices could adverse effect on our operations and financial condition. Any failure to comply with the laws and regulations could subject our Group to liabilities which may affect our business, financial condition, operational results and prospects.

#### Risks Relating to the Countries in Which We Operate

Economic, political, legal and regulatory conditions in the countries in which we operate may materially and adversely affect our business, financial condition, results of operations, prospects and the market price of our Shares.

We have operations and investments in countries such as Thailand, Singapore, Indonesia, USA, and the PRC, each of which contributed 65.8%, 27.3%, 2.9%, 2.4% and 1.7% of total revenues, respectively. Accordingly, we are subject to the risks associated with our business activities in these countries. Our business, financial condition, operational results and prospects may be materially and adversely affected by a variety of conditions and developments in these countries including:


- inflation, interest rates and general economic conditions;
- · civil unrest, military conflict, terrorism, change in political climate and general security concerns;
- changes in legal and regulatory conditions;
- changes in duties payable and taxation rates;
- natural disasters;
- imposition of restrictions on foreign currency conversion or the transfer of funds; or
- expropriation or nationalisation of private enterprise or confiscation of private property or assets.

#### Risks Relating to an Investment in Our Shares

Our foreign ownership restrictions could limit your ability to transfer our Shares and limit our ability to raise equity financing.

Our Articles of Association provide that no more than 49.0% of our Company's issued and outstanding Shares may be held by non-Thai persons. Our Articles of Association also provide that transfers of Shares in violation of applicable foreign ownership limitations may be restricted. In the event that the applicable foreign ownership limitations have been reached, Thai Shareholders may not be able to transfer their Shares to persons who are non-Thai nationals. As a result, the liquidity and market price for our Shares may be adversely affected.


The report committees conducted the stakeholders' survey for all sustainability issues exposed in the report. Their comments and suggestions would be collected to use for improvement in the next report.




#### Business Overview and Economic Performance

Financial status of the company as of December 31, 2016 could be described as follows:

Total income of 77,907.50 million baht is mainly from sales. It has been increased from 2015 for 15,973.73 million baht (20% increase) with sales volume increased to 1,494,094 tons (25% increase), and the production capacity has been increased to 2,371,745 tons by capacity expansion in 2016.



#### Support for Religious Activities

We are proud to create employment in the agricultural community. 
## Employees' Care


- 1. Knowledge and understanding about the organization

## Benefits and Compensations



In 2016, Sri Trang Group has adjusted the welfare of medical expense for more coverage.


#### Fringe Benefits

- Proper and sufficient communication and training for safety, occupational health and working environment for employees





### Career Path





Sri Trang in cooperation 3 provinces, Trang, Nakorn Sri -Thamarat, Suratthani Provincial Governor's Office initiate this project to slow down the water flow in the rainy season caused of flooding and mudslide, prevent and mitigate drought, and watershed areas will absorb and hold water that will support people's water consumption and agriculture throughout the year.



#### 6. "Sharing Water, Sharing Life" Project

Sri Trang offer to help the community fight a drought in their area. We agreed to support a water in the dry season to provide community in agriculture and personal consuming by survey the need of the community in each of dry season.



#### 7. "Sri Trang Friend of Farmer"

Natural rubber raw materials from farmers are the main source of Sri Trang Raw material. At Sri Trang we give first priority to rubber farmer well being and also contribute in providing information, knowledge to Rubber Farmers on how to make high quality rubber sheet, cup lump, Field latex. What cause the contamination and suggest how to store the rubber stock in order to prevent contamination and increase the quality. The right coagulant agent to be use, the consequence of wrong usage of coagulant product and test kits to differentiate the contaminant coagulant agent. Also promote safe transporting vehicle for cup lump transporter to ensure no harm on environment cause by the serum from the fresh cup lump. Safe transportation and roads for the supplier and community. Together with University who came out with design and Sri Trang support on installation and promote to the supplier nation wide.



#### 8. "Release Local breed fish in the wild"

Joining with the university to provide the fish breed to support the community and life style and reduce the hunger in unfortunate area. Fish still be the good source of food for the villager around Thailand. Over fishing and extreme long drought period might cause reduction of fishes in the wild. Sri Trang support the community through this activities in varies location to ensure community wellbeing.



#### 9. "Sri Trang Library"


#### 10. "School playground"

They will be in charge to review its operation in line with environmental management ISO 14001 and also have annual meeting of 2015-2016 (January 2015 - June 2016), which will cover every relevant part of the operation, as well as finding an conclusion for the next improvement.





- Water resources are both operational cost and essential resources for production. Water management will be a key indicator of effectiveness in doing business of Sri Trang Group. Then business performance will be reviewed and pursued by Top management in every quarter.
- Water management is to manage water to be enough for use and be quality adequately. Also, water quality will not be affected to the communities surrounded the plant.
- Define a goal of more effective water use annually and also a goal of recycled water.



## Co-operation Development in Water Management

Water management is a key of operating business. The pilot project of water management, under specialists from Water Institution for Sustainability, the Federation of Thai Industries, is jointly carried out with goals as follow:

- 1. Estimate water distribution at present
- 2. Improve to increase efficiency or reduce operating cost
- 3. Build standard in water management in organization

There are 18 plants to join the project and they've operated continuously. Sri Trang Agro-Industry Plc. was chosen as the project model in 2015 as well.

### Staying with Community Sustainably

The plants in northeastern part have dug wells to keep water from rainfall as water reserve to use in the factories and provide to the rice-growing area. For example, Rubberland Products Co., Ltd's Buriram Branch has distributed water through pipe to the farmers in the dry season. While sediment, which stems from water treatment system, has been sent for analysis to find heavy metal contamination, following the law on 2005's industry waste. The analysis finds that there is not heavy metal contamination. Also, it found that there is nitrogen which is an essential nutrient for plant growth, considered as fertilizer to grow stems and leaves. It was experimented in the plant and later was distributed to the company's staff or people nearby to use in growing plant.


# Climate Change and Energy **Conservation Operation**

- Sri Trang Agro-Industry Plc. has relied on energy for production. Then the company realizes climate change and global warming, caused by greenhouse gas emission
- Increase efficiency in using energy of production process, reduce its use and be environmentally friendly

Concerning on climate change and energy conservation has goals as follows:

- Choose energy-saving equipment
- Use alternative energy such as biomass fuel for rubber drying, instead diesel fuel
- Reduce the use of LPG gas at the plant
- Choose to produce during off peak
- Improve a process which will make raw material less moisture in order to reduce fuel in rubber drying
- Use biomass fuel from coconut shell and wood piece, which will be chopped as fuel, replacing LPG gas. It has applied to additional 3 plants.
- Measure air quality which flows out of the chimney every six month and its air quality, which is measured in every plant of the company, has passed all legal criteria in 2016.




Fuel Change from LPG to wood pieces to be chopped as fuel




Energy consumption average per technically specified rubber factories

### Build energy awareness to employees

By doing so, there are activities to be promoted. For example, it includes to encourage the company's employees in the plants to use cloth bag, instead plastic bags, use the recycled paper, ride bicycle in the plant, grow plants to increase a green area to reduce global warming and waste separation in order to promote the reuse and reduce its amount for disposal. Also, the company has joined the carbon footprint project of the products, which include rubber sheet, block rubber and concentrated latex, to assess carbon dioxide emission from production to shipping process with an aim to improve the production process to decrease carbon dioxide emissio in the future. Currently, there are 3 natural rubber products of 5 companies to receive the certified carbon label for B to B (Business to Business) from Thailand Greenhouse Gas Management Organization (Public Organization) and Anvar-Parawood Co., Ltd has received a certification on wooden pallet, which uses in containing technically specified rubber with STR standard. The company also has the reforestation project to increase the green area in the plants and communities, under the company's policy which wants to increase the green area in the plants and communities surrounded. The policy was launched since 2012.

# Raw Materials Management and Recycling

- Concentrate to reduce an impact on environment by maximizing benefits from the use of raw materials and materials for development and building values of materials used in the whole system from production to delivery to consumers
- Plan to manage resources, with a focus to increase efficiency of the process

The group of technically specified rubber has many production processes and use more materials and equipment. Then it has an amount of waste more than other groups. Non-hazardous waste include steel scrap from maintenance, plastic containers, while hazardous waste includes used oil from machine maintenance, ribbed smoked sheet rubber production, which use natural resources to produce water and electricity, a way which helps reduce the amount of waste. So is unused materials from uncomplicated concentrated latex production. The amount of waste is less.

Hazardous waste from engine oil change under work plan, unused materials of the plants is divided into groups as follows:



### The unused materials project

- Styrene-Butadiene Rubber (SBR) which contains synthetic rubber as raw material in the company's rubber compound production, or broken wooden pallet from work will be turne into shelves, shoe racks, tables, chairs, bookcases for internal use and giving to schools and communities which are short of equipment
- Bring sediment from rubber cup lump cleaning and microorganism sediment from water treatment with aeration system to turn it into microorganism for planting
- Destroy the former to be used to produce rubber gloves, which is ceramics to be sent to a small crushing machine. Ceramic pieces are analyzed. When finding nothing about hazardous materials or heavy metals contamination. It is used to fill road around the water treatment area and bring it to be a mixture of cement in casting pole, pouring concrete floor and putting into bag as big bag to prevent from flood

• The unused material project such as tape nylon to be turned into bag, steel scrap from maintenance to be turned into robot, plastic bottles to be turned into bin, wooden box to be turned into table for work and used fuel tank turned into chair. Encourage the use of environmentally friendly papers by using eco-fiber as an element in producing of 100%, by not using new wood pulp from any single tree for production, leading the environmentally friendly paper to have quality the same as paper produced from new wood pulp, used for the company's publication.

#### Recycling

Goal of unused materials management from the factories follows the 3R principle -"reduce, reuse and recycle".





#### Reduce

Reduce the water use is to use only its need and save it with an aim to onserve water resources for us to use sustainably



#### Reuse

Water Reuse Use reused water such as taking water from plate cleaning to pour plant, which not only help save money, but also help save water resources as well



### Recycle

Use of recycled water Use the recycled water which has passed a water treatment process before reusing it

- Separation and reuse
- Improve the working process to help reduce an amount of the hazardous and non-hazardous waste from the plants at the lowest level
- Use resources effectively
- Decrease waste disposal, which affects cost It started with a data collection of waste and unused materials from the factory with ISO 14001 before expanding to other factories. It has operated a process of unused materials management and defined a monthly data collection. Also, it has sampled the factories operation, along with an annual check of 5S of the quality department.

#### Waste Water


The company has standardized waste water management by checking the waste water quality which is treated following the legal definition of quality standard, with goals as follows:

- Develop a treatment system to be more effective
- Able to recycle water to use in the production of 100%, with a closed system design
- No water via the treatment system to be discharged into public canal




It is waste water treatment by using oxygen-using bacteria, which comprises of 2 parts as follows: Aeration Tank To fill air to make bacteria to degrade organic substance in water in the form of carbon dioxide and water

Sediment Tank Separation makes water clear and water on surface can be discharged into environment






It receives an oxygen filling from aerator which is installed as buoy or adhering with stand in order to increase enough oxygen in water. For microorganism, it can use to degrade organic substance in waste water faster than natural degradation

#### Air Pollution

Sri Trang Agro-Industry Plc. realizes an impact from rubber odor caused by smoking and odor from a pile of raw materials, which is a key element in production, which has no technology in the market to solve this absolutely. Then, the company is committed to developing technology in order to reduce it continuously, with goals as follows:

• Control odor situation from a pile of raw materials and odor from chimney in attempt to prevent an impact on community surrounding.

#### Air Pollution Management

- Concentrated latex factory with an installation of the ammonia vapor system before releasing to the outside, which helps reduce the amount of ammonia vapor in the working area
- Technically specified rubber factory with an installation of the air treatment and odor reduction system in two parts as follows:
  - 1. Air treatment system, with a cause from rubber smoking 2. Air treatment system, with a cause from rubber compound production, as well as the factory which uses boiler will install the wet scrubber system in order to treat air before releasing to the outside. The result of air quality after treatment passes all standard criteria imposed by law.
- Odor from a collection of cup lump rubber, with a solution by spraying wood vinegar in order to reduce its odor
- Examine efficiency of the odor treatment system from rubber smoking by setting up a team which is trained by the Pollution Control Department (PCD) and receives certification to examine odor following the PCD procedure. This working committee will examine a degree of odor concentration of the block rubber plant, which installs the air treatment system, following a specific period of time of air quality check in airflow from the chimney during 2013 - 2016.

## Research and Air Pollution Treatment Development

- Research and develop to find out a cause of odor and a solution of odor from natural rubber substantially
- Work with government agencies to campaign to reduce the use of coagulant agent for cup lump rubber, which is raw material of technically specified rubber and design test kit to use for contamination test
- Develop and improve the system of getting rid of odor with wet scrubber as bio-scrubber, which can increase its effective treatment and use less water of 10%
- The company has carried out the research and development in a joint operation with the Federation of Thai Industries to reduce odor from rubber smoking


