Declaration of Commitment to Net Zero

Sri Trang Agro-Industry Public Company Limited ("the Company") recognizes both the risks and opportunities arising from climate change, which may significantly impact our business operations and supply chain. The Company is committed to contributing to national and global greenhouse gas (GHG) reduction efforts in line with the Paris Agreement and Thailand's climate targets. To strengthen our climate resilience and enhance long-term business sustainability, we have established two key short-term and long-term targets that will guide our strategic and systematic climate actions as follows:

- 1. Reduce greenhouse gas emissions by 23% (Scope 1 and 2) from the 2024 baseline by 2030.
- 2. Achieve Net Zero emissions by 2050.

To drive Net Zero target, the Company has communicated its climate direction and targets across all levels of employees, ensuring organization-wide participation in compiling GHG emission data and developing reduction plans aligned with the Net-zero Pathway. This pathway is referenced against the Science Based Targets initiative (SBTi) and the Net Zero for Organization guidelines of the Thailand Greenhouse Gas Management Organization (Public Organization), both of which are widely recognized at national and international levels. These targets encompass the reduction of GHG emissions from production processes and direct energy use. We are driven by key initiatives, including enhancing operational efficiency through the integration of AI (Sri Trang AI Machine – SAM) with data management systems, increasing the share of renewable energy, adopting low-carbon technologies, and expanding low-carbon product development. These efforts will strengthen our competitiveness in a sustainability-driven market, enable tangible emission reductions, enhance resilience to climate-related risks and create new opportunities for long-term sustainable growth.

I am confident that Sri Trang's organizational culture—grounded in dedication, determination, and our shared belief in "**Driving Possibilities**"—will be a key force in advancing our Net Zero ambition. This commitment will position STA as a leading Green Rubber producer in Thailand and globally, while enabling sustainable business growth and delivering long-lasting value to our investors, society, and the environment.
